BOOKING CONDITIONS

1. The property known as Whitehouse Barns (“the Property”) is offered for holiday rental subject to confirmation by Mr Richard Griffiths or Mrs Penelope Roskell-Griffiths (“the Owner”) to the renter (“the Client”)
2. To reserve the “Property”. The client should complete and sign the booking form and return it together with payment of the initial non-refundable deposit, (30% of the total rent due). Following receipt of the booking form and deposit, the Owner will send a confirmation invoice and statement. This is formal acceptance of the booking.
3. The balance of the rent together is payable not less than two months before the start of the rental period. If due payment is not received by the due date, the Owner reserves the right to give notice in writing that the reservation is cancelled. The Client will remain liable to pay the balance of the rent unless the Owner is able to re-let the Property. In this event, clause 6 of these booking conditions will apply. Reservations made within two months of the start of the rental period require full payment at the time of booking.
4. Subject to Clauses 2 and 3 above, in the event of a cancellation, refunds of amounts paid, less the non-refundable deposit, will be made if the Owner is able to re-let “the Property”, and any expenses or losses incurred in so doing will be deducted from the refundable amount. **The client is strongly recommended to arrange a comprehensive holiday insurance policy (including cancellation cover) and to have full cover for the party’s personal belongings, since these are not covered by the owner’s insurance.**
5. The rental period shall commence at 4pm on the first day and finish at 10am on the last day. The Owner shall not be obliged to offer the accommodation before the time stated and the Client shall not be entitled to remain in occupation after the time stated.
6. The maximum number to reside in the “Property” must not exceed 5 plus one child in Upper Barn or 8 plus one child in Lower Barn unless the Owner has given written permission. Extra day guests in excess of five additional people need written permission. For larger parties using both barns, occupancy not to exceed thirteen without written permission.
7. The Client agrees to be a considerate tenant and to take good care of “the Property” and to leave it in a clean and tidy condition at the end of the rental period. Although a final clean is included in our prices, the Owner reserves the right to request additional payment to cover additional cleaning costs if the Client leaves the “Property” in an unacceptable condition. The Client also agrees not to act in any way which would cause disturbance to those resident in neighbouring properties.
8. The client shall report to the Owner’s agent without delay any defects in the “Property” or breakdown in the equipment, plant, machinery or appliances in the “Property”, or the grounds, and arrangements for repair and/or replacement will be made as soon as possible.
9. The Owners reserve the right to terminate the agreement without refund of money if the behaviour of any holidaymaker is considered unacceptable or if the number of occupants exceeds that stated in the property description.
10. The Owner shall not be liable to the Client:
 - i. for any temporary defect or stoppage in the supply of public services to the “Property”, nor in respect of any equipment, plant, machinery or appliance in the Property or grounds.
 - ii. For any loss, damage or injury which is the result of adverse weather conditions, riot, war, strikes or other matters beyond the control of the Owner.
 - iii. For any loss, damage or inconvenience caused to, or suffered by, the Client if the “Property” shall be destroyed or substantially damaged or for any other reason unavailable before the start of the rental period and in any such event, the Owner shall, within seven days of notification to the Client, refund to the Client all sums previously paid in respect of the rental period.
 - iv. For any accident, damage, loss, injury to person or property.
11. Under no circumstances shall the Owner’s liability to the Client exceed the amount paid to the Owner for the rental period.
